The Board of Director PT Sekar Laut Tbk ("SKLT" or "Company") hereby announces that:

General Meeting of Shareholders ("AGM") dated May 10, 2021 has decided the payment of cash dividends for the year 2020 in the amount of Rp9,324,996,750. (Nine Billion Three Hundred Twenty Four Million Nine Hundred Ninety Six Thousand Seven Hundred Fifty Rupiahs) or the amount of Rp 15. (Fifteen Rupiahs) per share which will be paid as follows:

2. Payment Procedure :

- a. Cash dividends paid to shareholders whose names are registered in the Register of Shareholders of the Company and / or shareholders of the Company at the Securities Sub Account in PT. Indonesian Central Securities Depository ("KSEI") on 28 May 2021 at 16:00 pm (recording date).
- b. For shareholders whose shares are included in the Collective Custody at KSEI, the cash dividend will be paid through the account holder in KSEI.
- c. Shareholders whose shares are not included in the Collective Custody at KSEI (still using the script), the Company will carry out the distribution of dividends by check or transfer to the account of the Shareholders. Shareholders are required to notify in writing the Name of Shareholders, Shareholders Address, Name & Address Bank and account number to the Board of Directors, Jl. Raya Darmo 23-25, Surabaya 60265. Tel. (031) 567-1371, Fax. (031) 567-2318, no later than 28 May 2021.
- d. The cash dividend will be taxed according to the tax laws that apply in Indonesia.
- e. Shareholders who are taxpayers in the form of a legal entity which has not included a Taxpayer Identification Number (TIN) are required to submit TIN to KSEI or BAE not later than on 28 May 2021 at 16.00 pm. Without the inclusion of TIN, cash dividends paid to domestic taxpayer is subject to article 23 in accordance with applicable regulations.
- f. Shareholders who are Foreign Taxpayers, can use rates based on the Avoidance of Double Taxation Agreement (P3B) shall meet the requirements of article 26 of Law No. 36 of 2008 and to submit a Certificate of Domicile (SKD) has been legalized by Tax Office for Listed Companies to KSEI or BAE not later than on 28 May 2021 at 16.00 pm, in the absence of SKD intended, dividend paid will be charged Income Tax Article 26 in accordance with applicable regulations.
- g. Shareholders whose shares are in collective custody at KSEI, evidence dividend withholding tax may be taken in the securities company and / or custodian bank where the shareholders open a securities account and for shareholders script can be taken at the company's office, street Raya Darmo 23-25, Surabaya 60 265, Tel.
